













PROTESTS:

Any protest must be presented in writing to the Contest Director and must be accompanied by the deposit of a fee of 50 Euros.

The protest must clearly state which rule or procedure/process in the Sporting Code was not followed or violated, and what restitution is expected. The protest fee is refundable if the protest is upheld by the FAI Jury.

Please take note that a protest is usually the last resort, if no satisfactory result has been obtained after an inquiry and then an official complaint. Please review, FAI Sporting Code General Section and CIAM General Rules.

The deposit is returned only if the protest is upheld.

Complaints against the judging criteria of judges cannot be admitted as protests.
